Law Major Core: (LAW 401, LAW 402A, LAW 402B, LAW 404)

Law Major Core courses have a prerequisite of POL 201.

Generally, students do not begin the Law Major Core until their Junior Year.

Recommended to only take one Law Core Course per semester and start with LAW 402A or LAW 402B

LAW402A and LAW402B are writing emphasis courses.

Law Core Courses are offered in-person during these semesters only:

LAW 401 & LAW 402A = In-Person, Fall semesters only

LAW 402B & LAW 404 = In-Person, Spring semesters only

Law Major Writing Requirement:

Students receiving a “B” or better in ENGL 102, 108, or 109H must complete 1 LAW or POL writing emphasis course with a “B” or better. Students receiving a “C” or worse in ENGL 102, 108, or 109H must complete 2

LAW or POL writing emphasis courses and earn a “B” or better in one and a “C” or better in the other.

Writing Emphasis courses are marked with an * on the following page.

Math Requirement: There are no DRC Math substitutions allowed in the LAW major. It is highly recommended that students complete either SBS 200 or MATH 112 or higher before their junior year.

Study Abroad:

Always meet with your major advisor before selecting courses for Study Abroad.

The Law Major has approved Global Tracks (<https://international.arizona.edu/study-abroad/tracks/law>) in several UA Study Abroad locations, but students can study abroad in other places as well.

Students who plan to study abroad should save certain courses early such as the SBS Core series and the SGPP Elective. Again, always meet with your advisor to discuss your specific circumstances and plans.

Internships are not required in the Law BA. Students may receive academic credit for internships if the internship is approved in advance. There is no retroactive credit awarded for past internships. Work with your internship coordinator to determine if an internship is appropriate for academic credit.

- A maximum of 6 units of internship credit in total may be used toward overall major requirements
- A maximum of 3 units of internship credit may be used toward LAW elective requirements
- A maximum of 3 units of internship credit may be used toward POL elective requirements
