Book Project: *Toxic Representation: How representative politics threatens democratic legitimacy*

(Completed Three of Five Chapters. Anticipated Completion of the manuscript and submission to Cambridge University Press for review by August 2024)

Gender Oppression in Politics addresses various changing political realities, including, most notably, how women increasingly occupy leadership positions while continuing to be significantly under-represented in democratic institutions. This book attempts to update our understanding of gender oppression in politics in light of the complicated status women have in politics. Gender oppression is not, then, to be envisioned as women being completely constrained and immobilized: the mobility of some women is won at the cost of impeding the mobility of others. Oppression can no longer be adequately understood simply as the social and political structures that allow men to monopolize political power. We need to recognize how oppression is dynamic, how individuals can be constrained and erect barriers for others, and how the coordination of barriers can continue to impede women's advancement, even when some women are granted political power.

Thus, gender oppression should no longer be understood as the male *monopoly* of political power but rather as an *oligopoly*. Male dominance in politics is perpetuated by the coordinated control that existing elites have over access to and influence within democratic institutions. In particular, I explain how elites and their audiences are both responsible for erecting and sustaining gendered political hierarchies via an intersubjective process I call political misogyny. This process has three necessary stages: 1) representatives advance "*nasty claims*" about women in politics; 2) those nasty claims activate negative gender associations in the relevant audience; and 3) members of this audience accept the nasty claims as

their own. Understood in this way, political misogyny distorts the public's perception of how women perform in politics, increases distrust of women, and distracts attention away from their political agendas.

To understand the dynamics of contemporary gender oppression, we must attend, not only to the political subordination of women to men, but also to how gender oppression can be served by white women aligning with white men, and by the construction of hierarchies among different groups of women. Building on my work on absences and accountability, I attend not just to the norms and practices that make women hated and relatively more absent in politics, but also to those that make existing representatives less accountable to and responsive to the needs of vulnerable democratic citizens. And I explore how representatives, women as well as men, can contribute to the marginalization of women in democratic politics.
